## Privacy Policy

Welcome to Huddersfield Carnival's Privacy Policy.

**Q:** Does Huddersfield Carnival share my information with outside parties?

**A: Absolutely Not!**

All our members and interested parties of Huddersfield Carnival can feel confident that their information will not be sold or rented to any third parties. Personal data, such as billing or shipping information, is NOT stored on our secure servers.

### What Information Does Huddersfield Carnival Collect?

We receive and store any information entered into the website or that you may give us in any other ways such as email, chat or phone communication.

We use the information provided to assist you with your support requests, questions, tracking, to improve our site and communicate with you.

When ordering products and/or registering on the site, we ask that members provide certain information so we can create a member profile and customize preferences for each specific user. This also gives us as a more efficient method for contacting you about your service, should the need arise.

We receive and store information whenever you interact with the website. For example, like many websites, we use "cookies" to obtain electronic information when your Web browser accesses Huddersfield Carnival or any other Huddersfield Carnival documents. Some companies offer utilities designed to allow you to visit websites anonymously. ### Cookies

Cookies are bits of electronic information that a website can transfer to a visitor's hard drive to help tailor and keep records of visits to the site. Cookies allow website operators to better customize visits to the site and cater to the visitor's individual preferences. The use of cookies is standard on the Internet. Although most Web browsers automatically accept cookies, you can usually change your browser to prevent cookies or notify you each time you are sent a cookie. This gives you the chance to decide whether or not to accept it. If you choose to not accept cookies, you could still have access to most of the features on the site. However, Huddersfield Carnival uses cookies so that they can help provide visitors with a better experience.

### **Security of Personal Information**

We work to protect the security of your information during transmission of sensitive/credit data by using Secure Sockets Layer (SSL) software, which encrypts information you input. This personal data is contained behind secured networks and is only accessible by a limited number of employees who have special access rights to such systems.

### **Kids under 13 (Special Note to Parents)**

Pursuant to the provisions of the Federal Children's Online Privacy Protection Act (COPPA), we do not collect information from children under thirteen years of age without the consent of a parent or legal guardian. Parents, or legal guardians, may provide us with consent to collect such information by email, by facsimile or by posted mail. Parents may request to review information collected from their child, may ask to have that information deleted, and may refuse to allow further collection or use of the child's information. To request such review or to give instructions regarding the information we have collected about a child, parents or legal guardians should contact us.

We encourage parents and guardians to spend time online with their children, to participate in the interactive activities offered online, and for children to consult with their parents before submitting any information to this or any other website. Although guests under eighteen years of age may be allowed, with their parent's permission and supervision, to participate in noted contests, if such a guest wins, notification and prizes will be sent to that guest's parent or guardian.
